- To provide vocational training and start income generating programs for persons with

disabilities and formation of self-help groups.

- To protect the rights of persons with disabilities.
- To implement Community Based Rehabilitation Programmes for PwDs. To undertake extension and outreach programmes in the sawaimadhopur.
- To run old age home for the aged, shelter home for deserted and destitute persons.

Mental Retardation is a condition of arrested or incomplete development of the mind, which is especially characterized by impairment of skills manifested during the developmental period, skills which contribute to the overall level of intelligence, that is, cognitive, language, motor and social abilities.

Characteristics of Mental Retardation

- 1. Absence of clarity
- 2. Age inappropriate behavior
- 3. Delay in development
- 4. Inability to decide
- 5. Inability to learn fast
- 6. Inability to understand quickly
- 7. Inability to remember
- 8. Lack of concentration
- 9. Lack of motor coordination
- 10. Slow reaction

MUSKAN SPECIAL SCHOOL CUM REHAB CENTRE FOR MULTIPLE DISABILITIES:

Muskan Special School cum Rehab Center for Multiple Disability under the aegis of Mercy Rehabilitation Society, Sawaimadhopur. The school runs under the scheme known as Deen Dayal Upadhyal Rehabilitation Scheme of Ministry of Social Justice and Empowerment, New Delhi. The special school is equipped with the latest technology in the field of disability rehabilitation. The teachers are qualified and registered under central rehabilitation register of rehabilitation council of India, New Delhi. School is facilitating comprehensive rehabilitation services to the children with intellectual disability.

The Centre is providing education and training to children with intellectual disability and other disability in order to develop their innate potential to the maximum. The school has strength of 47 children with disability. The service activities include psychological assessment, physiotherapy, occupational Speech Therapy, therapy, parents counseling etc. The center has equipped with teaching learning material teaching the children with disability. The Centre also conducts regular curricular and co-curricular activities for them.

The children with disability have equally participated in the co -curricular activities. Mercy Rehabilitation Society has organised awareness cum plantation program in which they have participated during the program. In addition educational aspects, the children also celebrated Holi in the premises of Mercy Rehabilitation Society, Sawaimadhopur. They enjoyed Holi. The children visited Museum and enjoyed the moment.

NATIONAL ENVIRONMENT AWARENESS CAMPAIGN:

NIRAMAYA HEALTH INSURANCE:

A Health Insurance Scheme for the welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities has launched by Ministry of Social Justice and Empowerment, New Delhi. Health insurance is the one of the best possible support for children with disability. The parents of children are very poor economy level. They cannot afford a good medical checkup. They can access good health checkup. Therefore Niramaya Health Insurance plays a very significant role. Mercy Rehabilitation Society, Sawaimadhopur has enrolled 33 children with developmental disabilities under Niramaya Health Insurance. The facility available in the scheme is not in general health insurance for persons with disability.

OPEN SHELTERS FOR CHILDREN IN NEED:

Mercy rehabilitation society has been running open shelter for children in need in urban area under the integrated child protection scheme (icps), a centrally sponsored scheme of government-civil society partnership of Ministry of Women & Child Development, Government of India since 2015-16.

The largest numbers of homeless children, street and working children, child substance abusers and child beggars, left on their own and in need of care and support, reside in urban areas. They are seen living in conditions of extreme deprivation compounded by lack of shelter and access to basic services like sanitation, safe drinking water, education, health care, recreational facilities, etc.

ICPS caters to the needs of children including, prevention, treatment and rehabilitation through open shelters. This flexible mechanism is catering to the unique needs of these children particularly in urban areas and aims to harness their talent and potential, thus giving them the opportunity to become productive citizens. The open shelters is a place for children where they can play, study, use their time productively and engage themselves in creative activities through yoga & meditation, indoor and outdoor games, etc. in a safe environment and located within their own community.

This activity encourage meaningful peer group participation and interaction and ensures the overall growth and development of children and keeps them away from socially deviant behaviours, in addition to fulfilling their basic requirements for food, nutrition and health. The open shelter also has provisions for health care, quality and flexi-time education (including connecting with mainstream schools).

Target Group

Mercy Rehabilitation Society covered a total of 15 children through open shelter in urban areas to cater to all children in need of care and protection particularly beggars, street and working children, street performers, orphaned, trafficked and run-away children, children of migrant population, children living in unauthorized areas/slums in the financial year 2015-16.

Mercy rehabilitation society has taken care of children and worked for the rehabilitation. They were enrolled in the shelter and after some time they were placed to their family or some non-governmental organisation for their further improvement.





PARENTS AWARENESS PROGRAMME:

The Mercy Rehabilitation Center has been conducting parents awareness programme to the development of appropriate rehabilitation services at the center premises every month. Thus a total of 10 such meetings were conducted by the institute during the financial year 2015-16. In this program the parents of children with intellectual & developmental disabilities have been actively participating and sharing their views & opinions which strengthens the performance of the center.

HOME VISITS BY PROFESSIONALS:

Apart from the Centre based rehabilitation services to the children with intellectual & developmental disabilities, this institute has been also extending its services in home based environment. Under this, the professionals are visiting the houses of the needy persons with severe / multiple disabilities probably on Saturday and providing need based intervention in the home based environment by using local teaching & training materials. They are also providing training to the parents / siblings and motivating them to achieve good results.

INDEPENDENCE DAY CELEBRATION:

The organization has arranged a special function on the eve of Independence Day celebrations on 15.08.2015 at the special school premises. On this occasion Sri Arvind Singh, Secretary of Institute had hoisted the National Flag and appreciated the faculty members, parents and children for good cause of action for the rehabilitation of children with intellectual disabilities.

CELEBRATION OF INTERNATIONAL DAY FOR PERSONS WITH DISABILITY:

The children of Muskan Special School and Rehab Center have participated International Day for Persons with Disability, 3rd December, 2015.
