It is also registered under section 52 (2) of Persons with Disability Act, 1995 wide registration number 295 / Jaipur 2010-11 dated 27.01.2011 and under section 12 (4) of The National Trust for The Welfare Of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities Act, 1999 wide Registration number 091218331426028 / MR / CP / AUTISM / MD dated 19.12.2013 and 12 AA Registration under Income Tax Act, 1961 IC/ITO(T)/Kota/12 AA/2014-15/688 and 80 G Registration under Income Tax Act, 1961 wide Registration number IC/ITO(T)/Kota/12 AA/2014-15/689 dated 19.06.2014 with the noble cause to render all sorts of services. It is also

registered with Department of Education, Sawaimadhopur and NITI Aayog.

- To conduct special camps in rural & urban areas for identification.
- To provide vocational training and start income generating programs for persons with disabilities and formation of self-help groups.
- To protect the rights of persons with disabilities.
- To implement Community Based Rehabilitation Programs for disabled.
- To undertake extension and outreach programs in Sawaimadhopur.
- To run old age home for the aged, shelter home.

MUSKAN DAY CARE SPECIAL SCHOOL FOR CHILDREN WITH DISABILITIES UNDER DDRS:

Mercy Rehabilitation society, Sawaimadhopur has registered under the Person with disability Act and running special school for children with disability namely Muskan day care Special School for children with disability. It is under the aegis of Ministry of disability welfare, Government of India, New Delhi a well-known programme Deen Dayal Upadhyal Rehabilitation Scheme. The special school is equipped with the latest technology in the field of disability rehabilitation. The teachers are qualified and registered under central rehabilitation register of rehabilitation council of India, New Delhi. School is facilitating comprehensive rehabilitation services to the children with intellectual disability.



The special school is running to provide educational as well as therapeutic intervention for the children with disability. The children with disability are getting training in extra co-curricular activities also. The children are using their innate potential for the learning of different things. Special school is providing educational and training to children with disability and other disability in barrier free environment. They are learning with peer also as we made peer group in the school.



The children with disability also explore the day to day activities. We used to celebrate the birthday of children at schools so that they can enjoy the moment and understand the occasion. They also remember the others' birthday. We as social animal and living in society, children must expose from those activities which is celebrated. The children are coming from home every day therefore they are also exposed with the rout and road by which they are move.

As the children are with severe and profound category therefore we are focusing on the activities of daily living so that they can do their activities of daily living independently. They are trained in brushing, grooming, combing, buttoning and unbuttoning, and other activities. The children with disability have equally participated in the co-curricular activities. They were also exposed with festival can doing such activities before the festival at special schools for children with disability.



School has 28 children with disability. These are as follows:

The service activities include psychological assessment, physiotherapy, occupational therapy, Speech Therapy, parents counseling etc. The center has equipped with teaching learning material for teaching the children with disability. The school conducting its regular curricular and co-curricular activities for children. They are

also learning 3R i.e. reading writing and arithmetic in barrier free environment taught by qualified special educator. The children with disability have been performing activities of daily living independently.



OPEN SHELTERS FOR CHILDREN IN NEED:

Mercy rehabilitation society has been running open shelter for children in need in urban area under the integrated child protection scheme (icps), a centrally sponsored scheme of government–civil society partnership of Ministry of Women & Child Development, Government of India since 2015-16.

The largest numbers of homeless children, street and working children, child substance abusers and child beggars, left on their own and in need of care and support, reside in urban areas. Open Shelter Home is with the approval of Child Welfare Directorate, Rajasthan. We opened Provident Fund account, ESI for all staff who are working with us.

The main purpose of shelter home is to provide food, stay and other things on temporary base for the homeless, orphan or who away from home. A total of 80 such children got benefited with shelter home and they returned to their home. Rehabilitation of those children is purpose of shelter home. The counselling session were conducted for their parents. It was very challenging task to know the address and returned children to their home that left home. We worked for children to reach their home who are from Delhi, Uttar Pradesh, Madhya Pradesh and different districts of Rajasthan. Return them to their family is very challenging task. Staff did work very carefully and intelligently. 80 such children enrolled temporally in the shelter home in this financial year.

Shri Arvind Singh Chauhan, Secretary, Mercy Rehabilitation Society got awarded by Smt. Anita Bahdel, Hon'ble Minister, Women and Child Development,

Government of Rajasthan on the occasion of Republic day 2017. Shri K C Verma, District Collector, Sawaimadhapur had gracious presence during the award ceremony. The district collector appreciated the work of staff for this work.

The organisation worked for dozen children to mainstream who were collecting polythin and garbage from Bawariya village of the district. They were enrolled in school for education of those children and for their future. Shri Prashant Chaudhari, Sachiv Jila Vidhik Seva Pradhikaran, Sawaimadhapur appreciated for the work done by organisation. Also aware hundred children for going to school. All children enrolled in shelter home returned to their home.



RESIDENTIAL SPECIAL SCHOOL FOR CHILDREN WITH MULTIPLE DISABILITIES:

Children with severe and multiple disabilities pose unique challenges to educators. Such children need more individual support and care than a normal child. The services for such children are gaining focus and importance in the country with the recognition of this disability under the National Trust Act (1999). It is essential that service providers must have a good understanding of Children with multiple disabilities, when decisions are made about interventions and the plans and strategies for their implementation. In the district of Sawaimadhopur, a very limited services available to Children with multiple disability. Children with multiple disabilities are suffering due to this and they are not getting adequate knowledge and skills with respect to requirement. There is strong requirement of Residential Special School for Children with multiple disabilities at Sawaimadhopur to provide services to these children. In this regards, Director, Special Abled, Social Justice and Empowerment Department, Government of Rajasthan, Jaipur has given opportunity to Mercy Rehabilitation Society to run Special Schools for multiple disability. It has started on 3rd December, 2016. A total of 30 children are enrolled in residential set up.

The objective of special schools are as follows:

- Children can do daily living independently.
- All-round development of the child.
- Communication with the world around is most severely affected
- To develop ability to move around in the environment.
- Need regular help in simple day-to-day activities such as wearing a shirt, opening a door, finding a chair to sit down and so on.
- A highly structured educational / rehabilitation programme helps in their training etc.



Regional Parents Meet 2016-17

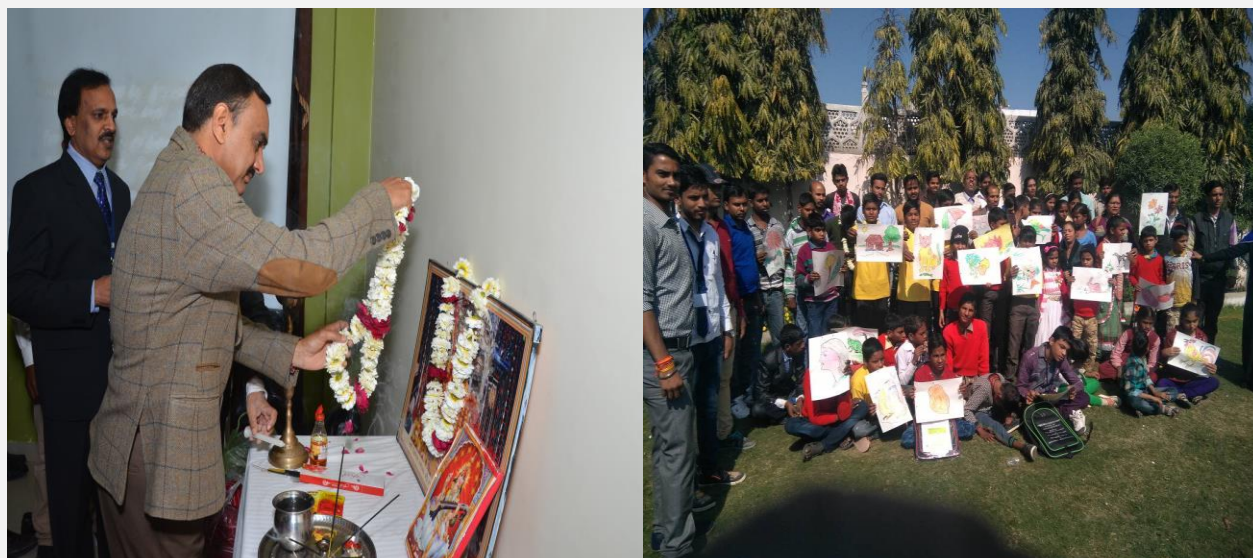
